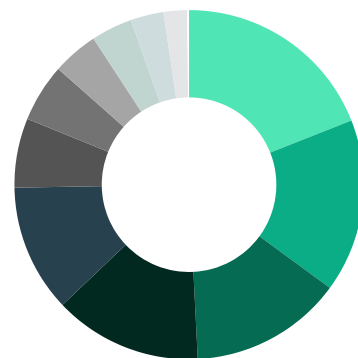

**Important Risks**

For example, the Fund incurs operating expenses and portfolio transaction costs not incurred by the Index. In addition, the Fund may not be fully invested in the securities of the Index at all times or may hold securities not included in the Index. **Index Calculation Risk.** The Index relies on various sources of information to assess the criteria of issuers included in the Index, including fundamental information that may be based on assumptions and estimates.

**Glossary:**

**Bloomberg US 600 Index:** Bloomberg LP ("Bloomberg") is the licensor of the Bloomberg US 600 Index. Bloomberg US 600 Total Return Index is a float market-cap-weighted benchmark of the lower 600 in capitalization of the Bloomberg US 1500 Index (B1500).

**Market Price:** The current price at which shares are bought and sold. Market returns are based upon the last trade price.

**NAV:** The dollar value of a single share, based on the value of the underlying assets of the fund minus its liabilities, divided by the number of shares outstanding. Calculated at the end of each business day.
